Prof. M. L. Schroff, the Father of Pharmacy Education in India remains a role model to all the Pharmacists working in this country regardless of their branches and diversity of duties. He played a great role in building the pharmacy profession. Prof. Schroff started the M. Pharm Education in 1940 at Banaras Hindu University. Gradually, the pharmacy education sprung up in different places in India.

Pharmacy Council of India has decided to recognize the contribution of Prof. Mahadeva Lal Schroff for establishing the Pharmacy Education in India by declaring his 'Birth Anniversary' 06 March as "National Pharmacy Education Day".

### **Pharmacy Council of India**

Pharmacy Council of India is a statutory body operational under the Ministry of Health and Family Welfare, Government of India. It is founded under the Pharmacy Act, 1948 to standardize the pharmacy education & practice of profession in India. The Pharmacy Act 1948 was enacted on 4.3.1948 with the following preamble- "An Act to regulate the profession of pharmacy. Whereas it is expedient to make better provision for the regulation of the profession and practice of pharmacy and for that purpose to constitute Pharmacy Councils". The PCI was constituted on 9.8.1949 under section 3 of the Pharmacy Act.

National Education Policy, 2020 envisions an education system rooted in Indian ethos that contributes directly to transforming India, sustainably into an equitable and vibrant knowledge society, by providing high-quality education to all, and thereby making India a global knowledge superpower.
