Dear All,

The 1st National Virtual Moot Court Competition was organized by Moot Court and Debating Society, Faculty of Law on three consecutive days i.e., **19, 20, 21 of April 2022**. The first day of this mega event started off with much vigour and zest. The Inaugural Ceremony took place virtually through the YouTube channel of the faculty of Law and was live-streamed from 10:00 am onwards to 11:30 am on 19 April 2022. The Inaugural Session was started by **Mohd. Sufiyan Khan (Student Convener)** and the

welcome address were given by the **Dean and Head Dr. Naseem Ahmed (Chairperson, 1st National Moot Court)**. The **Chief Guest** for the occasion was **Dr. Humayun Rasheed Khan**, Addl. Director, Judicial Training and Research Institute, Lucknow and the **Guest of Honour** was **Adv. Rakesh Chaudhary**, Oudh Bar Association, High Court, Lucknow. Their presence and enlightening words thrust us forward into the competition.

Preliminary Round 1 of the Moot Court Competition started off at 11:40 am on the same day. The mooters and the Hon'ble Judges were invited to their respective courtrooms through google meet links. And so, the arguments began. The participants showed full potential with their arguments and contentions. The 2 Judges in each courtroom made sure to keep the teams on their toes by asking questions throughout the session. The specific courtrooms were managed by designated Court Masters who had the duty of coordination, timekeeping, proper order and affirmation of rules to the participants. 40 Courtrooms were in session at the same time and Round 1 was concluded without any hassle.

Preliminary Round 2 was scheduled after Round 1 from 1:15 to 2:00 pm. The new fixture was sent to all the participants with an updated list of Courtrooms and Court Masters respectively. After Preliminary Round 2, the 'Researcher Test' was scheduled at 5 PM on Google Forms for all researchers in the registered teams. The time allotted for the test was 15 minutes. And with this, the first day of the competition was over.

The results were declared in the evening and with this, the 4 teams proceeded to move into the Semi-Finals on 20th April 2022. We were glad to announce that following are the proud semifinalists of the Competition.

- University of North Bengal, TC 33
- Jindal Global Law School, TC- 15
- The Tamil Nadu Dr. Ambedkar Law University, TC- 32

Day 2 started with the commencement of the **Semi-Finals** from 11:00 am to 12:30 pm. The competition had gone up because the stakes were even higher. There were 2 courtrooms in session with the motive of getting the best two teams out of the 44 registered. The Judges grilled the participants even harder and made it all more difficult for the semifinalists. This cutthroat competition finally led to 2 Teams emerging victorious and reserving their spots for the awaited Finals. The teams which definitely set their mark on the pedestal and fought for the title of 'Winner, 1st National Virtual Moot Court Competition' were

Everyone looked forward to the Finals of this competition where arguments were raised back and forth, contention devised from either side and a bold stand was taken from all the Speakers. And after this mega session and clash of opinions, **Dr. Abhishek Kumar Singh** (Associate Professor) declared the results and the team that came out as 'Winner' was TC-32 Tamil Nadu Dr. Ambedkar Law University, Chennai. The Last highlight of the three-day enormous event was the **Valedictory Session**, which took place from

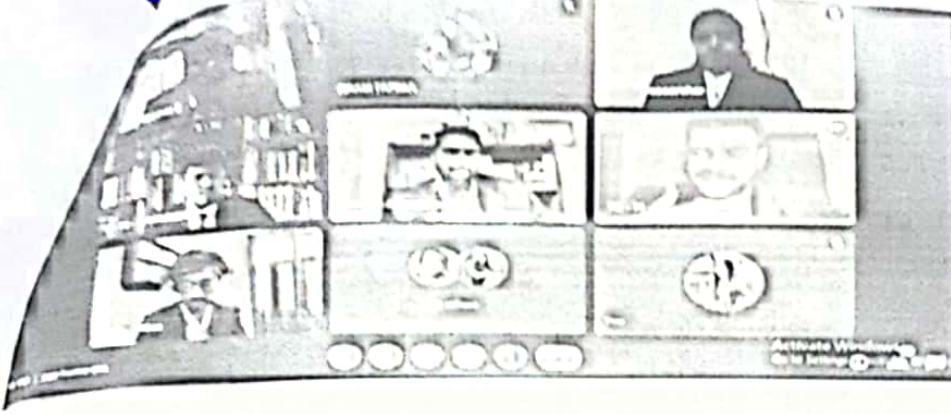
