

Dear All,

The Faculty of Law, Integral University, Lucknow has organized an Online-Value Added Course on 'Environmental Governance and Sustainability' from 4th July 2022 to 23rd July 2022. This course was specially framed for all the UG and PG course students of all departments throughout the university. **A total of 75 plus** students have registered out of which 58 students made themselves enrolled on ILI. The Course was conducted in July with the support of authority and faculty members who had smoothly completed the task to make it a complete success. This was a virtual mode course conducted every day where lectures were delivered 4 days every week in two sessions and 2 days were reserved for practice quizzes per week:

Monday to Saturday between 10:30 AM-12:30 PM/1:30-3:30 PM.

This interactive session was held on Google meet for the Lectures and ILI-LMS platform for quiz tests, assignments, and learning materials. The Participants were so curious as they were actively involved and had shown dedication and hard work to complete their assigned tasks on time as the course provided them with the basic knowledge about law and its importance in the present time with any kind of situation that a person might face in their day-to-day lives. All the participants who successfully completed the course were awarded e-certificates uploaded on LMS only on the basis of their quiz test, feedback for every unit, attendance, general feedback, and moreover 50% qualifying criteria for the course.

**Key Highlights of the VAC:**

- Students from various courses were eligible for the course.
- The Course registration was free for all.
- The Course is divided into 5 Modules.
- 42 Students successfully completed the course and got their e-certificates.
- Sessions were conducted through PPT using both Audio-Visual Modes.

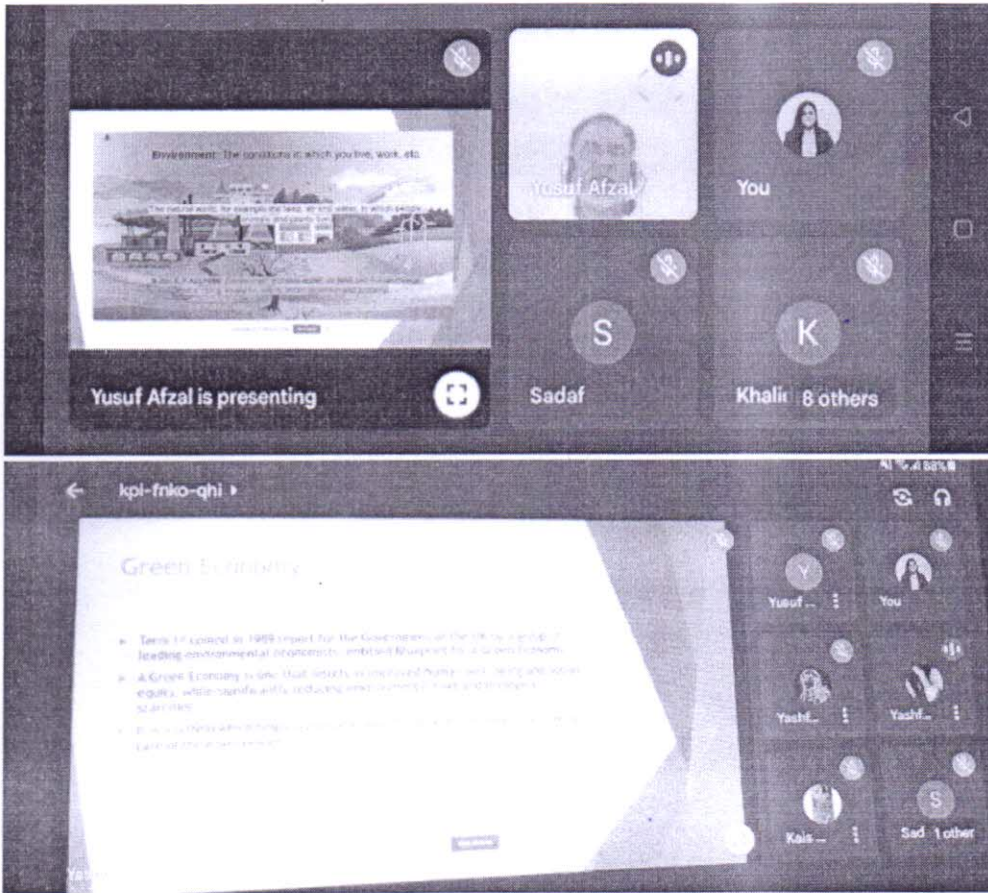
