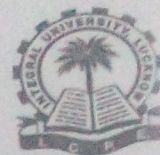

The Prime Objective of MOU is to make the students more employable under **Campus to Company (C2C) Program**, by way of providing Inplant Training, Academic Projects and job oriented skill development courses to be conducted by NSIC –TSC at Integral University Premises under Entrepreneurship Development Cell and at NSIC premises in Aligarh .



The Prime objective of the NSIC TSC is development of skilled manpower (Students) conduct tailor made courses to suite the industries requirement and to extend Common Facility Services to MSME units in Management & Engineering sectors.

1. **In plant Training** : NSIC-TSC to conduct in plant training in batches for at least 50 students from Management/Mechanical/Electrical/IT/ Engineering of second, third and final year respectively for a duration of five working days or as required from time to time and as per new Govt. Schemes. The University to intimate in advance regarding the dates on which the training to student would be conducted at Integral University Premises or students would be sent to NSIC TSC as required. The List of bonafied students to undergo training at our centre to be sent with a letter addressed to Chief General Manager, NTSC Aligarh, from the college along with the Demand Draft if required. Internship shall be given for final year students with the duration of 1 month at a nominal fee.
2. **Customised Training Programmes** : Different Training Modules as per Institution requirement, options available for in-house and on-site Training.
3. **Academic Projects/ Mini projects / Internship**  
NSIC TSC will also extend support in Academic projects for final year students and miniproject for 2<sup>nd</sup> or 3<sup>rd</sup> year students at a nominal fee. Its mandatory for students who enroll for projects to attend class on project as per the scheduled framed by the project coordinator.

5. **Technical Seminars/workshops:**  
NSIC TSC will support Technical seminars/workshops for Mechanical/IT /MBA/BBA & B.Com branches based on their requirements
4. NSIC -TSC to assist on placement.
5. **The validity of this MoU is till 31<sup>st</sup> March 2018**



TERMS AND CONDITIONS:

1. Bonafied letter from college to be submitted by the student for IPT/Internship/project.
2. University identity card must be carried by the student during the training period.
3. The fee if required shall be paid in demand draft in favour of NSIC Ltd. A/c NTSC Aligarh.
4. The college would ensure proper discipline and conducive atmosphere will be maintained throughout the training course. The candidates will be issued certificate when they fail to maintain punctuality and attendance
5. On Successful completion of training, a certificate will be issued to the candidates.
6. NSIC-TSC will also help in Startup and Entrepreneurship Development.
7. NSIC-TSC will assist in availing facilities through various schemes of NSIC for Entrepreneurship Development
