# MEMORANDUM OF UNDERSTANDING

This MoU made on this. 28 day of Francisco, Two Thousand Twenty between Council of Scientific and Industrial Research, a Society registered under the Societies Registration Act XXI of 1860 having its registered office at Anusandhan Bhawan, 2 Rafi Marg. New Delhi-110 001 (hereinafter called CSIR which expression shall where the context so admits, include its successors and permitted assigns) through its CSIR-Central Drug Research Institute having its office at Sector 10, Jankipuram Extension, Sitapur Road, Lucknow-226031, India, (hereinafter called CSIR-CDRI) of the one part.

#### And

Integral University, Kursi Road, Lucknow 226026 India (hereinafter called IU which expression shall where the context so admits, include its successors and permitted assigns) of the other part.

Each CSIR-CDRI and IU here under are also referred to separately as the ("Party"), or together as the ("Parties")

#### CSIR-Central Drug Research Institute, Lucknow

WHEREAS CSIR-CDRI is a pioneer drug research institute having all the infrastructure facilities for and development of new drug from conceptual to commercialization stage including SAR, QSAR, combinatorial synthesis, bioinformatics, proteomics, genomics, regulatory toxicology, pharmacology pharmacokinetics, pharmaceutics and expertise in conducting and coordinating clinical trials.

#### Integral University, Lucknow

WHEREAS IU is established under the Act Number 9 of 2004 by the State Government. The University is duly approved by the University Grants Commission (UGC) under sections 2(f) and 12B of the UGC Act, 1956, Medical Council of India, Pharmacy Council of India, Indian Nursing Council, Council of Architecture, Bar Council of India, Indian Association of Physiotherapists, National Council for Teacher Education, UP State Medical Faculty and Distance Education Bureau.

Integral University is accredited by NAAC and recognized as a Scientific & Industrial Research Organization (SIRO) by the Department of Scientific & Industrial Research, Ministry of Science & Technology, Government of India

#### 1.0 Scope of the MoU

This MoU which is for five (5) years is established to provide collaborative cooperation through:

# i) Collaborative Research Programs in specific fields of interest

CSIR-CDRI and IU will jointly identify specific fields to conduct collaborative research programs of mutual interest and benefit to both parties.

#### ii) Student Exchange Programs

Exchange programs for students will be explored and conducted accordingly which will be beneficial mutually for both the parties.

# iii) Faculty Exchange Programs

Exchange programs for faculty will be explored and conducted accordingly which will be beneficial mutually for both the parties.

## iv) Sharing of Instrumentation Facility

The facilities shall be used as per the prevailing guidelines of the institutes.

# v) Submission of Joint projects-

Project proposals may be jointly submitted to DBT, CSIR, DST, ICMR or any other funding agencies for extramural funding for carrying out further studies of selected project/molecules.

### 2.0 General Provisions

The MoU shall remain valid for a period of five (5) years from the last date of signing of the MoU.

- The collaborators shall initiate the work after obtaining necessary approval of the research project from Institutional Animal and Human Ethics Committee of CSIR-CDRI and IU respectively.
- The progress of implementation of the program shall be reviewed by IU and CSIR-CDR! as mutually decided and the benefits of the collaboration shall be shared mutually.
- Iv. Both parties shall take necessary financial approvals from the competent authority for fulfilling the scope of the program under clause 1 on case to case basis.

Both parties and their student can visit the collaborating institutes as per requirements of the project, and shall have adequate insurance coverage without any financial liability on each other.

The parties shall consult each other for any publication in respect of research work. These publications (papers, reports etc.) shall be in the names of actual research workers wherein it will be duly acknowledged that the work has been carried out under the collaborative research program of CSIR-CDRI and IU. As a part of collaboration, the outcomes of the research under this MoU shall develop joint publication.

- vii. Any publication, document and/or paper arising out of joint work conducted by the participants pursuant to this MoU will be jointly owned. The use of the name, logo and/or official emblem of the participants on any publication, document and/or paper will require prior permission of both the participants. It may however be ensured that the official emblem and logo are not misused.
- Applications for joint patents will be filed in the name of institutions namely CSIR, and IU. Lucknow.
- ix. Both parties agree to ensure appropriate protection of Intellectual Property Rights generated from such cooperation consistent with their respective laws, rules and regulations.
- x. In case research is carried out solely and separately by a Party or the research results are obtained through the sole and separate effort of a Party, the Party concerned alone will apply for grant of IPR and once granted the IPR will be solely owned by the concerned Party.
- xi. In case of research results obtained through joint activities, the grant of intellectual property rights will be sought by both the parties jointly and once granted these rights will jointly owned by the parties on mutually agreed terms and conditions.
- xii. In case of research results obtained through joint activities under this MoU both parties will apply as co-applicants for the protection of intellectual property rights subject to exclusive rights of both the parties to commercialize the technology jointly on mutually acceptable terms and conditions.
- xiii. Any expenditure towards filing, maintaining and securing of IPR, development of the product and revenue towards license fee and royalty shall be shared on case to case basis in mutual consultation between Director, CSIR-CDRI and Vice Chancellor, IU under a separate agreement.
- xiv. Any product generated under the program shall be licensed to any industry by CSIR-CDRI and IU jointly under a separate agreement after mutual consultation between CSIR-CDRI and IU towards the fulfillment of point (xiii) stated above.
- xv. Once the product generated under the PROJECT is licensed to any industry(ies), CSIR-CDRI & IU shall ensure that the licensed company shall affix in a conspicuous manner upon every Finished Product and/or mode of packaging containing the Finished Product a label or plate bearing the inscription "A joint product by CSIR-

CDRI &IU " in letters of size not less than half the nominal size of the largest size of letters giving either the name of the company or its brand name or trademark for the Finished Product along with the logo of CSIR-CDRI & IU. The licensed company shall not sell Finished Product and/or any box or package containing the Finished Product without such label or plate being affixed thereon and shall also abide by the guidelines of other countries for the appropriate visibility of CSIR-CDRI &IU. Similarly, every advertisement, hoarding, technical literature, publicity and like material in respect of or relative to the Finished Product issued by the company shall include the same inscription as aforesaid in a prominent manner.

he annual maintenance of the facility including all the instruments shall be the esponsibility of each party without any financial liability on each other.

Nothing contained herein shall constitute this a partnership or joint venture agreement or constitute either party as the partner, principal or agent of the other, this being a MoU between independent contracting entities

No amendment or modification of this MoU shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications shall be effective from the date on which they are made, unless otherwise agreed to.

Both parties shall do their utmost to ensure the smooth and efficient implementation of the program.

XX The parties will use their best efforts to settle all matters in dispute amicably. All disputes and differences of any kind related to this MoU shall be jointly settled between Director, CSIR-CDRI and Vice Chancellor, IU.
