

MEMORANDUM OF UNDERSTANDING

Sharing a common desire to explore, extend and strengthen the functional relationship between Integral University (IU), Lucknow and Bioved Research Institute of Agriculture& Technology (BRIAT), Allahabad in order to share the facilities and expertise available in each other's institution herewith sign a Memorandum of Understanding (MoU), which reads as follows:

1. Integral University, Lucknow will provide registration facilities for Ph.D Degree in Seed Technology/ Plant Breeding Plant Pathology/Plant Physiology/ Entomology/Agronomy/ Horticulture /Botany /Zoology /Biotechnology/Life Sciences/Bioengineering/Bioinformatics and allied Subjects to BRIAT sponsored candidates with M.Sc./M.Tech degree in appropriate subject. Scientists at the BRIAT institute may be allowed to register for Doctoral programmes for the award of Doctoral degree by the university The Guide/Co-Guide will be from Integral University which shall be decided as per the provision of PhD Ordinance of Integral University, Lucknow.A list of competent scientists and their CVs will be

provided by the Director, BRIAT to obtain a formal approval from the appropriate academic body of Integral University, Lucknow,

Ph.D /M.Tech/M.Sc. students working at Integral University, Lucknow would be able
to carry out a part of their research work at BRIAT, Allahabad and for such students
BRIAT Scientists will be a co-guide. BRIAT will be happy to provide necessary
aboratory facilities.

BRIAT will provide short term training to students and faculty members of the Integral University, Lucknow in their areas of specialization.

Traince's will work on BRIAT projects, pertaining to aspects of Horticulture/ Microbiology/ Biotechnology/ Molecular taxonomy/ Genetical behaviors and other front line areas as per the mandated activities of the Institute.

- Integral University, Lucknow and BRIAT, Allahabad may apply for collaborative projects jointly to National and International funding agencies.
- 6. The above MoU will be effective minimum for a period of five years.
- 7. This MoU reflects the respective institutions commitments to terms and conditions mentioned in the MoU. This MoU may be amended at anytime and terminated after completion of five years time by either party provided that notice of termination or amendments is provided by the notifying party to the other party within thirty (30) days of the date on which the termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.
- 8. The students attached in BRIAT of Integral University, Lucknow who will, while working / undergoing of Ph.D cause any damage to any part of the laboratory /instruments due to negligence of the student then they will be held responsible for the damage and the cost involved in damage will be recovered from the student either by the concerned University or BRIAT.
- The Integral University /BRIAT will have the responsibility only to provide the laboratory facilities. The expenditure for the high cost consumable material required for the study should be met out by the students themselves.
- 10. While carrying out of the study at Integral University, Lucknow /BRIAT, the discipline's Head of the department of the Integral University / Director, BRIAT will be the controller of the student and they will be bound to get permission to leave the place of the study of university/BRIAT from the controlling authority.

11. The working/ stay hours of the student will be fixed as per the discretion of the Integral University, Lucknow/BRIAT, Allahabad.

12. The student will be expected to protect the Intellectual Property Rights (IPR) generated or likely to be generated during his /her research work. The IPR shall rest with institution where the major part of the research work was carried out by the student. In the event of equal amount of work being carried out at both the institutes, patents / protections/knowledge generated will be shared in proportion as per the ICAR tuidelines/University guidelines for Intellectual Property Management and Technology ansfer/ Commercialization as amended from time to time.

Research findings will be published jointly by both the parties, but the party communicating the publication/corresponding author will be held entirely responsible for the conclusions and interpretations reported.

- 14. The university/institute may invite BRIAT Scientists/Experts/Integral University faculty members as Visiting faculty members to deliver lecturers as per requirement of the university/institute in various courses/capacities. However, TA and DA may be borne by the university/institute. Suitable honorarium may also be given to concerned scientist/university staff as per university/institute rules. The university 'Integral University, Lucknow' and the institute 'BRIAT, Allahabad' may invite each other's faculty members on special occasions to develop strong linkages.
- 15. The BRIAT Scientist recognized by the Integral University, Lucknow and the research scholars who work at BRIAT for PG/thesis research shall be governed by relevant rules and regulations of BRIAT, Allahabad and Integral University, Lucknow respectively.
- 16. The research project to be undertaken by the student/research scholar shall be decided through mutual consultation between the student/research scholar, supervisor/guide, and co-supervisor/co-guide and shall normally be within the mandates of BRIAT/Integral University, Lucknow and priorities set by the BRIAT, Allahabad and the university.
- 17. Periodical meetings of the students/research scholars with supervisors/co-supervisors will be held either at the premises of institute or university.
- 18. A copy of the thesis shall be submitted at BRIAT, Allahabad after the award of the degree.
- 19. The Dean of the concerned faculty at Integral University, Lucknow and Director, BRIAT, Allahabad will be jointly responsible for working out the operational details of the agreement between the two organizations and ensure proper and effective implementation of the MoU. During the study period at both the institutes, the Principal/Head of the university/institute will be the controlling authority and the

candidate shall be bound to get permission to leave the place of work from the controlling authority.

This agreement will be in-effect from the date of signing this MoU by both the parties and renewed further if mutually agreed upon. Either party may terminate the agreement by written notification signed by authorized official of the institution initiating the notice. Such notice must be received by the other party six months prior to the effective termination date. However, obligations and commitments already contracted shall be nonored and continued by both the parties until such commitments are over. These commitments under agreement may be amended/modified/deleted after mutual agreement by means of exchange of letters between the institute and the university. Once approved by both the parties, such amendment shall also become a part of this Memorandum of Understanding (MoU)
