- 2. Ph.D/M.Tech/M.Sc. students working at Integral University, Lucknow would be able to carry out a part of their research work at RFRAC and for such students RFRAC Scientists will be a co-guide. RFRAC shall provide necessary laboratory facilities as per the terms and conditions, norms & fee structure of RERAC from time to time. The cost of the consumable goods and chemicals will be borne by the students/University during their dissertation/practical works in the concerned courses of the University.

Trainee's will work on RFRAC projects, pertaining to aspects of Food Technology/Food Biotechnology/Life Sciences /Food Microbiology/Biotechnology and other front line areas as per the mandated activities of the Institute and on terms and conditions mutually agreed upon by RFRAC and IU, Lucknow for such courses and projects.

- Integral University, Lucknow and RFRAC may apply for collaborative projects jointly to National and International funding agencies.
- 7. The above MoU will be effective minimum for a period of five years w.e.f. the signing of MoU,
- While carrying out the study at IU RFRAC the student shall be under the disciplinary control of the competent authority of the institution concerned.
- 9. The student shall protect the Intellectual Property Rights (IPR) generated or likely to be generated during his /her research work. The IPR shall rest with institution where the major part of the research work was carried out by the student. In the event of equal amount of work being carried out at both the institutes, patents / protections/knowledge generated will be shared in proportion as per the guidelines for Intellectual Property Management and Technology Transfer/ Commercialization as amended from time to time.
- 10. The IU/RFRAC may invite their Scientists/Experts/Faculty members reciprocally as visiting faculty members to deliver lecturers as per requirement of the IU/RFRAC in various courses/capacities. However, TA and DA may be borne by the inviting institution.

11. The Dean/Principal of the concerned faculty at IU, Lucknow and Director, RFRAC, Lucknow will be jointly responsible for working out the operational details of the agreement between the two organizations and ensure proper and effective implementation of the MoU. 12. This agreement will be in-effect from the date of signing this MoU by both the parties and renewed further if mutually agreed. Either party may terminate the agreement by written notification signed by appropriate official of the institution initiating the notice. Such notice must be received by the other party. Three months (90 days) prior to the effective termination date. However, obligations and commitments already contracted shall be honored and continued by both the parties until such commitments are over. These commitments under agreement may be amended/modified/deleted after mutual agreement by means of exchange of letters between the institute and the university.
