

MEMORANDUM OF UNDERSTANDING

Sharing a common desire to explore, extend and strengthen the functional changeship between Integral University (IU), Lucknow and Directorate of Seed research (DSR). Mau in order to share the facilities and expertise available in each other's institution herewith sign a Memorandum of Understanding (MoU), which reads as follows:

1. Integral University. Lucknow will provide registration facilities for Ph.D Degree in Seed Technology/ Plant Breeding / Plant Pathology/Plant Physiology/ Entomology/Agronomy/ Horriculture /Botany /Zoology / Biochemistry /Biotechnology/Life Sciences and allied Subjects to DSR sponsored candidates with M.Sc. degree in appropriate subject. The Guide/Co-Guide will be a scientist of DSR who will be at the level of RMP/Principal Scientist/Senior Scientist. A list of competent scientists and their CVs will be provided by the Project Director, DSR to obtain a formal approval from the appropriate academic body of Integral University, Lucknow.

- Ph.D /M.Tech/M.Sc. students working at Integral University, Lucknow would be able to earry out a part of their research work at DSR and for such students DSR Scientists will be a co-guide. DSR will be happy to provide necessary laboratory facilities.
- DSR will provide short -term training to students and faculty members of the Integral University, Lucknow in their areas of specialization.
- Trainec's will work on DSR projects, pertaining to aspects of Seed Science & Technology / Molecular taxonomy/ Genetical behaviors and other front line areas as per the mandated activities of the Directorate.
- Integral University, Lucknow and DSR may apply for collaborative projects jointly to National and International funding agencies.
- 6. The above MoU will be effective minimum for a period of five years.
- 7. This MoU reflects the respective institutions commitments to terms and conditions mentioned in the MoU. This MoU may be amended at anytime and terminated after completion of five years time or earlier if any controversy arises by either party provided that notice of termination or amendments is provided by the notifying party to the other party within thirty (30) days of the date on which the termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.
- 8. The students attached in DSR of Integral University, Lucknow who will, while working / undergoing of Ph.D cause any damage to any part of the laboratory /instruments due to negligence of the student then they will be held responsible for the damage and the cost involved in damage will be recovered from the student either by the concerned University or DSR.
- The Integral University /DSR will have the responsibility only to provide the laboratory facilities. The expenditure for the high cost consumable material required for the study should be not out by the students themselves.
- 10. While carrying out of the study at Integral University, Lucknow /DSR, the discipline's Head of the department of the Integral University / Project Director, DSR will be the controller of the student and they will be bound to get permission to leave the place of the study of university/DSR from the controlling authority.
- The working/ stay hours of the student will be fixed as per the discretion of the Integral University, Lucknow/DSR.

- 12. The student will be expected to protect the Intellectual Property Rights (IPR) generated or likely to be generated during his /her research work. The IPR shall rest with institution where the major part of the research work was carried out by the indient. In the event of equal amount of work being carried out at both the institutes, extents / protections/knowledge generated will be shared in proportion as per the ICAR guidelines for intellectual Property Management and Technology Transfer/
 Commercialization as amended from time to time.
- 13. Research findings will be published jointly by both the parties, but the author/guide communicating the publication will be held entirely responsible for the conclusions and interpretations reported.
- 14. The university/institute may invite DSR Scientists/Experts/Integral University faculty members as Visiting faculty members to deliver lecturers as per requirement of the university/institute in various courses/capacities. However, TA and DA may be borne by the parent employer. Suitable bonorarium may also be given to concerned scientist/university staff as per university/institute rules. The university 'Integral University, Lucknow' and the institute 'DSR, Mau' may invite each other's faculty members on special occasions to develop strong linkages.
- 15. The DSR Scientist recognized by the Integral University, Lucknow and the research scholars who work at DSR for PG/thesis research shall be governed by relevant rules and regulations of ICAR and Integral University, Lucknow respectively.
- 16. The research project to be undertaken by the student/research scholar shall be decided through mutual consultation between the student/research scholar, supervisor/guide, and co-supervisor/co-guide and shall normally be within the mandates of DSR/Integral University, Lucknow and priorities set by the DSR, Mau and the university.
- Periodical meetings of the students/research scholars with supervisors/co-supervisors will be held either at the premises of ICAR institute or university.
- 18. A copy of the thesis shall be submitted at DSR, Mau after the award of the degree.

This agreement will be in-effect from the date of signing this MoU by both the parties and renewed further if mutually agreed upon. Either party may terminate the agreement by written notification signed by authorized official of the institution initiating the notice. However, obligations and commitments already contracted shall be honored and continued by both the parties until such commitments are over. These
