Any delay or failure by any party to perform its obligations hereunder shall be excused if any and to the extent that it is caused by an event or occurrence beyond the reasonable control of the Party and without its fault or negligence, such as, by way of example and not by way of limitation, actions by any governmental authority (whether valid or invalid), fires, floods, windstorms, explosions, riots, natural disasters, insurgency, wars, sabotage, labor problems (including lockouts, strikes and slowdowns), inability to obtain power, material, Jabor, equipment or transportation or court injunction or order; provided that written notice of such delay (including the anticipated duration of the delay) shall be given by the affected Party to the other Party within ten (10) days. If requested by any of the Parties, the other Party shall, within ten (10) days of such request, provide adequate assurances that the delay shall not exceed thirty (30) days. If the delay lasts more than three months, the requesting Party may, by written notice to the other Party, recommend cancellation of this MOU to the Governing Council without liability.
