## MEMORANDUM OF UNDERSTANDING

Tashkent Chemical-Technological Institute (hereinafter called TCTI) situated at 32, Navoi street, Tashkent, 100011, Uzbekistan, represented by the Rector **Botir Usmonov**, on the one part, and Integral University (hereinafter called IU) situated at Dasauli, Kursi Road, Lucknow, 226026, India, represented by the Pro Chancellor **Dr. Syed Nadeem Akhtar**, on the other part, hereinafter jointly referred to as «the Parties», guided by mutual interest in cooperating in the spheres of education and research, whereas a decision on joint mutually beneficial activities have been taken, now therefore the Parties have agreed to conclude this Memorandum of Understanding (MOU).

### 1. PURPOSE OF MOU

The purpose of this MOU is to establish partuer relations (academic and scientific cooperation) in the spheres of Chemical Engineering, Food technology, Biotechnology, Ecology, Mechanical Engineering, Economics, etc.

### 2. PROPOSED MODES OF COLLABORATION

The Parties agree to develop the following collaborative activities:

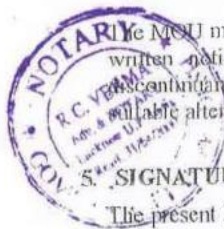
- a. To establish a Joint working committee with members from both parties, under the headship of Dean Research & Development, Integral University
- b. To encourage exchange of academic, research and administrative staff for experience exchange, lecturing, research, training, participation in conferences and other events
- c. To facilitate exchange of PhD, Master and undergraduate students in order to develop academic mobility
- d. To jointly organize seminars, conferences, workshops, short-term continuing education programs, etc.
- e. To conduct joint scientific research
- f. To contribute to joint educational and research projects, both bilateral and international
- g. To exchange, jointly prepare and publish educational, methodical and research materials
- h. To organize e-learning programs, Double degree diploma and joint programs
- i. To collaborate in other fields of mutual interest.

### 3. TERMS AND FINANCIAL RELATIONS

Cooperation activities, terms and financial relations shall be additionally discussed during planning of each event. A specific plan should be proposed in written form and discussed between the Parties. The plan should ensure all appropriate arrangements for the payment of expenses involved.

#### 4. MOU VALIDITY PERIOD AND TERMINATION

The present MOU shall become effective on the date that it is signed by both Parties and shall be valid for a period of five years. The MOU can be changed or revised. All changes and amendments are concluded in written form, and signed by the authorized representatives of the Parties.



The MOU may be terminated by either Party at any time provided that the terminating Party gives written notice of its intention at least six months prior to termination. In any case of discontinuance, the Parties will honor agreed commitments either via the accepted arrangement or available alternative negotiated at that point.

#### 5. SIGNATURES TO MOU

The present MOU is drawn up in two copies in English language, one copy for each Party, which have the same legal force.
