MEMORANDUM OF UNDERSTANDING (MoU)

## **BETWEEN**

INSTITUTE OF CO-OPERATIVE AND CORPORATE MANAGEMENT, RESEARCH AND TRAINING, LUCKNOW

and

INTEGRAL INSTITUTE OF AGRICULTURAL SCIENCE AND TECHNOLOGY, INTEGRAL UNIVERSITY, LUCKNOW

This memorandum of understanding is made on 05 February, 2024 between the Institute of Co-operative and Corporate Management, Research and Training (herein after referred to as ICCMRT and as first party), Lucknow and Integral Institute of Agricultural Science and Technology, Integral University (herewith in after referred as IIAST and as second party) Lucknow sharing a common desire to explore, extend and strengthen the functional relationship in the academic, human resource development, research, consultancy and other academic activities.

Whereas the parties have mutually agreed to conduct the following activities in order to develop new dimensions in the fields of education, research, training, consultancy etc.

- 1- Collaborative Study
- 2- Research & Consultancy
- 3- Education and Training
- 4- Exchange Programs & Study Visits

Now this MoU witnesses as under-

- 1) The two parties will apply for collaborative projects jointly on mutually agreed terms to the state, national, and international funding agencies.
- 2) The two parties will provide the space for specified training with all tangible and other resources as per availability.
- 3) The two parties will work for Skill & Entrepreneurial Development of students and faculty members of both institutes in the fields of Agriculture. Cooperative, and its allied sectors.
- 4) The first party will assist the students and faculty members of the second party in the execution of government projects and in the field of agriculture, cooperatives, and allied sectors.
- 5) Financial benefits will be shared equally between the parties after netting all the expenses incurred in the concerned program or project.
- The student/faculty member will be expected to protect Intellectual Property Rights (IPR) generated or likely to be generated during their research work. Both parties will have equal rights on Patent/Protections/Knowledge generated as per guidelines of **IPR** (Intellectual Property Management Technology Transfer/Commercialization Act as amended from time to time), Research findings will be published jointly. The research projects will be undertaken by students, research scholars, and faculty members and shall be decided through mutual consideration between both parties through its faculty members and supervisors, The faculty members of both parties will be jointly responsible for working out the operational details of the agreement and ensuring proper and effective implementation of the MoU.
- 7) The MoU shall remain effective for three years from the date of its singing. It would be terminable by either of the parties by giving one month's notice to each





other. If no dispute or differences are raised between them, then the MoU shall be automatically extended for another period of two years.

- This MoU may be modified/amended on mutual agreement of both parties. Any amendment notified by both parties shall become a part of the MoU.
- It is understood that if any dispute or differences arise in respect to terms and conditions of the MoU shall be settled in the office/s of the Director/s of the first & the second party who shall be the sole authorities and the mutually agreed decisions shall be binding on both parties.
