MEMORANDUM OF UNDERSTANDING

Sharing a common desire to explore, extend and strengthen the functional relationship between **Integral University, Lucknow, India** (herein after also referred as IU) and **Paktia University, Paktia, Gardiz, Afghanistan** (herein after referred as PU), in order to utilize the facilities and expertise available in each other's institution and broadly in the following (included but not restricted to) domains of partnership:

- a. Exchange of Students
- b. Exchange of Academic Staff
- c. Joint Research and publications
- d. Joint Conferences, Workshop and Seminars
- e. Provision of dual degree and other programs
- f. Mutual Visit of Academic and Non-academic Staff and Students
- g. Joint Industry consultancy
- h. Admission support activities
- i. Joint Placement activities.



We herewith sign a Memorandum of Understanding (MoU), which reads as follows:

1. Integral University, Lucknow/ PU, Paktia will provide mutual registration facilities for academic programs as allowed by respective University guidelines.
2. Students working at Integral University, Lucknow would be able to carry out a part of their research work at PU and for such students PU faculty will be a co-guide(s)/co-supervisor(s). PU will be happy to provide necessary laboratory facilities. Such students and supervision shall be governed by relevant rules and regulations of PU and IU. This shall also be equally applicable for such PU students working in IU.
3. The research project to be undertaken by the student/ research scholar shall be decided through mutual consultation between the student/research scholar, supervisor/ guide, and co-supervisor/co-guide and shall normally be within the mandates of PU/IU and priorities set by the universities.
4. Periodical meetings of the students/research scholars with supervisors/co-supervisors will be held either at the premises of PU, Paktia or at Integral University, Lucknow.
5. IU & PU will be happy to provide mutual short-term training to students and faculty in their areas of specialization and in other areas if required.
6. Integral University, Lucknow and PU, Paktia may apply for collaborative projects jointly to National and International funding agencies

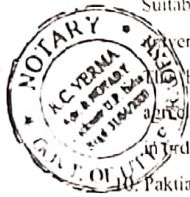

7. All joint research findings will be owned jointly by both the parties, but the party publishing them will be entirely responsible for the conclusions and interpretations reported.
8. Both the Universities may invite PU/UG faculty members as visiting faculty members to deliver lectures as per requirement of the university in various courses/capacities. Suitable honorarium may also be given to concerned scientist/university staff as per university rules and terms agreed in advance separately for each activity.
9. Head/Dean/Director of the two universities will be jointly responsible for working on the terms of and working out the operational details of individual activity in order to ensure proper and effective implementation of the MoU.
10. Paktia University and Integral University will both provide career consultancy to the Afghanistan / Indian students desirous of taking admissions in exclusively or mutually run courses (Medicine / Engineering /MBA etc.) at either of the university.
11. Integral University wishes to collaborate with Paktia University, Paktia, Afghanistan in the arrangement and delivery of industry oriented joint consultancy projects.
12. Integral University shall also explore with the active help of PU, the possibility of placement of students in the two countries or a third country with organizations of repute. We shall share resources and information on the same, as appropriate.
13. Any specific activity developed under this MoU shall be discussed and agreed upon in writing by both Universities prior to initiation. Specific points with regards to financial terms, facilities to be mutually provided & modus operandi in these matters shall be outlined and agreed upon under separate document(s) and signed by authorized officials from both the universities.
14. No point in this MoU shall entail any financial or legal obligation on either Universities, unless a separate agreement is reached between the two universities with specific reference to a specific activity.
15. The above MoU will be effective minimum for a period of three years from the date of signing. This MoU reflects the respective institutions commitments to terms and conditions mentioned in the MoU. This MoU may be amended at anytime and terminated after completion of three years time by either party provided that notice of termination or amendments is provided by the notifying party to the other party within thirty (30) days of the date on which the termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement

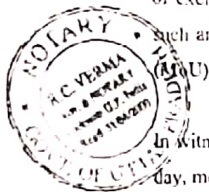

arises from any Supplementary Agreements resulting from this Memorandum of Understanding

16. However, obligations and commitments already contracted shall be honored and continued by both the parties until such commitments are over. These commitments under agreement may be amended/modified/deleted after mutual agreement by means of exchange of letters between the universities. Once approved by both the parties, such amendment shall also become a part of this Memorandum of Understanding
