A report on Pharmacy Council of India sponsored 'Pharma ANVESHAN 2024' on March 6, 2024 organized by Faculty of Pharmacy,

Integral University, Lucknow

The Pharmacy Council of India is actively working towards the implementation of the National Education Policy, 2020. Pharmacy Council of India sponsored the Faculty of Pharmacy, Integral University to celebrate the "National Pharmacy Education Day 2024" on 6th March, 2024 to commemorate the birth anniversary of Prof. M. L. Schroff, "Father of Pharmacy Education in India". Faculty of Pharmacy, Integral University, Lucknow organized 'National Pharmacy Education Day 2024' based Pharma ANVESHAN 2024 on the theme 'Leveraging Synergism: Industry-Academia Partnership for Implementation of National Education Policy 2020'. The theme was designed to bridge the gap between the industry and academia within the existing Pharmacy Course Curriculum.

Inaugural Session:

Prof. (Dr.) Syed Misbahul Hasan, Dean, Faculty of Pharmacy, Intergal University welcomed the dignitaries and participants. He emphasized the pivotal role of National Education Policy 2020 and enlighten the objectives of Pharmacy Council of India for conduction of the Pharma Anveshan 2024. He reiterated the need for outcome-based education and the need to impart vocational training to the students as well as the choice of the student to select discipline of his/her choice. The NEP 2020 has all built in aspects to provide the five pillars of education access, equity, quality, affordability and accountability. His address resonated with the audience, underscoring the significance of pharmacy education with industry experts and academicians. He appreciated the participation of the dignitaries who have come across from different places in spite of their busy schedule.

Dr. Ravi Kumar Trivedi, Vice President and HOD of the BA-DMPK division at Zydus Research Centre delivered his lecture and discussion on "Role of NEP on evolving Pharmacy Education

System". He enlightened about the determination of pharmacodynamic- pharmacokinetic estimation of drug molecules through advance analytical technologies that would positively catalyse the drug development and discovery at various stages and how the industry and nation's requirements can be met through experiential and participatory learning through adequate changes in the curriculum. He further suggested that the curriculum should be designed in a manner that the graduate becomes industry ready through intermediate with training during the time the student pursue a particular degree. His motivational and outstanding lecture engaged the audience with latest facts and figures in the field of Pharmacy. Dr. Ravi Trivedi also visited Integral Referral Analysis and Research Laboratory of Integral Centre of Excellence for Interdisciplinary Research.



Prof. (**Dr.**) **Manoj Kumar Shukla**, Director, Government Engineering College, Kannauj delivered his talk on "Education Policy System in India from the ancient era to till date".
