(2nd December, 2024)
Organized by: Faculty of Pharmacy, Integral University, Lucknow**

The **Department of Pharmacy, Integral University**, under the aegis of the **Mulya Pravah Committee**, a Quality mandate initiative, organized an awareness event to observe **National Pollution Prevention Day** on **December 2, 2024**. The event was held in alignment with **PO-10: Environment and Sustainability**, aiming to sensitize students about the environmental challenges and the need for sustainable solutions. The theme for the event was: **"Clean Air, Green Earth: A Step Towards Sustainable Living"** this theme emphasized the urgent need to adopt eco-friendly practices to reduce pollutants affecting our air, water, and soil. Historical Context

National Pollution Prevention Day is observed annually on December 2nd in memory of the **Bhopal gas tragedy** of 1984, one of the world's worst industrial disasters. The accident involved the release of **methyl isocyanate gas** from the Union Carbide India Limited (UCIL) pesticide plant in Bhopal, leading to thousands of deaths and long-term health and environmental consequences. This day serves as a poignant reminder of the importance of pollution control and stringent safety regulations in industries and communities.

Theme and Objectives

The event theme, **"Clean Air, Green Earth: A Step Towards Sustainable Living"**, was aimed at promoting public awareness and encouraging actions that support environmental health and sustainability. It called for collective responsibility among individuals, communities, and institutions to reduce pollution and protect natural ecosystems.

National Pollution Prevention Day 2024 also aligned with several **United Nations Sustainable Development Goals (SDGs)**:

- **SDG 3:** Ensure healthy lives by reducing pollution-related illnesses.
- **SDG 6:** Improve water quality and reduce hazardous chemical discharges.
- **SDG 7:** Promote clean and renewable energy solutions.
- **SDG 11:** Make cities sustainable and reduce urban pollution.

- **SDG 13:** Take urgent action to combat climate change and its impacts.
- **SDG 15:** Protect, restore, and promote sustainable use of ecosystems.
