The Constitutional Law Society (CLS) of the Faculty of Law, Integral University, in collaboration with the Gender Champion Club, Women Study Center, and Women Grievance Cell, proudly organized an Intra-University Speech Competition titled "ORATOR's ARENA". The event aimed to enhance students' public speaking, critical thinking, and persuasive skills by providing them with a meaningful platform to express their views on important legal and social issues. The central theme of the competition was "Rethinking Feminism in Light of Meninism: A Small Step, Big Change" (पुरुषवाद के आलोक में नारीवाद पर पुनर्विचारः एक छोटा कदम, बड़ा बदलाव), which encouraged thoughtful discussion on gender perspectives and the evolving understanding of feminism and meninism in the modern context.

The speech competition was bilingual and open to all undergraduate and postgraduate students of Integral University. It was conducted in two phases: the **Preliminary Round**, held on **4th March 2025**, saw participation from over **30 students** from various departments across the university. The top 10 participants from this round advanced to the **Final Round**, which was held on **8th March 2025**, as part of the **International Women's Day celebrations**. The competition concluded with the announcement of the winners: **Saanhvi Srivastava** (B.B.A. LL.B, 1st Year) secured the **1st Rank in English**, and **Alija Malik** (B.B.A. LL.B, 3rd Year) secured the **1st Rank in Hindi. Hussain Abdullah** (LL.B, 2nd Year) was declared the **1st Runner-up**, and **Sara** (B.B.A. LL.B, 1st Year) received the **2nd Runner-up** position. All winners received medals and certificates, while **e-certificates** were awarded to all registered participants as a token of appreciation.

The event successfully promoted gender sensitivity and student engagement while fostering legal awareness and communication skills among the students.
